

A background Note on the implementation of 100% Centrally Sponsored Schemes of Government of India Ministry of Agriculture, Department of Animal Husbandry, Dairying & Fisheries (DADF) New Delhi

Name of Department: **Animal Husbandry, U.T. Chandigarh**

I. LIVESTOCK HEALTH & DISEASE CONTROL

1. Assistance to States for Control of Animal Diseases Control (ASCAD)

This is a component of Centrally Sponsored Macro Management Scheme “Livestock Health and Disease Control (LH& DC)” and is being implemented in U.T. Chandigarh since 2003-04 with 100% central assistance . This schemes aims at to control and eradicate economically important animal diseases namely Foot & Mouth , Hemorrhagic Septicemia , Peste des Petits Ruminant (PPR) and Rabies in U.T. Chandigarh. Under this 100% CSS, prophylactic vaccinations are carried out to control these diseases. Awareness camps are organized in different places in Chandigarh as a part of information & communication campaign regarding above diseases. The Non Govt Animal Welfare Organisations namely SPCA & PFA are associated in the vaccination of animals. The Joint Director, Animal Husbandry & Veterinary Officer, Govt. Veterinary Hospital, Manimajra have been designated as Nodal Officers for implementation of the scheme. Under this scheme the emergent and exotic diseases of animals are also taken care of.

A sum of Rs 8.00 lakh is required during 2014-15 to implement the scheme

2) Establishment & Strengthening of existing Veterinary Hospitals and Dispensaries” (ESVHD)

This is a component of Govt. of India’s Centrally Sponsored Macro Management Scheme “Livestock Health and Disease Control (LH& DC)”. The scheme was taken up in 2012-13 with 100% central assistance for strengthening of existing Govt veterinary hospitals & sub-centers for extending quality services to livestock owners. A sum of Rs 7.04 lakh was incurred out of total funds of Rs 9.90 lakh for purchase of items of furniture, and equipments to Strengthen existing Government Veterinary Institutions in U.T. Chandigarh..

During 2013-14 & 2014-15 , this CSS is not proposed to be taken up. Thus no funds have been demanded/ required.

3) National Animal Disease Reporting System (NADRS)

This is a component of Govt. of India’s Centrally Sponsored Macro Management Scheme “Livestock Health and Disease Control (LH& DC)”. The CSS is being implemented as per guidelines of GOI, MOA, DAD & F , New Delhi to develop computerized system of timely animal disease reporting Online data regarding various animals diseases is updated on NADRS application website through NIC, Chandigarh on monthly basis. No funds demanded / required during 2012-13 , 2013-14 & 2014-15.

4) National Control Programme on Brucellosis

This is a component of Govt. of India’s Centrally Sponsored Macro Management Scheme “Livestock Health and Disease Control (LH& DC)”. Under this scheme it is proposed to undertake strategic vaccination of all female calves between 6-8 months in UT Chandigarh during 2013-14 against Brucellosis as a preventive measure .No funds

have been provided by Governments of India Ministry of Agriculture, (DADF) New Delhi up to December 2013 nor any guidelines have been received for implementation of the scheme..

A sum of Rs 0.40 lakh is required during 2014-15 to implement the scheme

II. INVESTIGATION & STATISTICS

i) Assisting the States / U.Ts. in the Conduct of 19th Livestock Census/ Breed Survey of livestock

The GoI, Ministry of Agriculture, (DADF) New Delhi has entrusted the task of conducting 19th Livestock Census & breed survey of livestock to the Animal Husbandry Department, Chandigarh Administration on 100% financial assistance. The department conducted and completed the 19th Livestock Census in Chandigarh with reference date 15-10-12 during 2012-13 in rural /urban areas of U.T. Chandigarh. It also completed Breed Survey of livestock in the month of July 2013 in the rural areas as a sequel to 19th Livestock Census during 2013-14

A sum of Rs 20.41 lakh was incurred during 2012-13 for conducting 19th Livestock Census. A sum of Rs 6.69 lakh is required during 2013-14 under the scheme

A sum of Rs 1.00 lakh is required during 2014-15 to implement the scheme

ii) Integrated Sample Surveys for estimation of Production of Major Livestock Products :

This scheme is being implemented in UT Chandigarh since 1981-82 with 100% central assistance. Regular seasonal surveys for estimation of production of major livestock products, breeds, composition and other related data like feed and fodder consumption by animals, utilization of milk, eggs and utilization of dung etc are carried out and compiled. To run the scheme staff consisting of a Research Officer, a Statistical Assistant, a Field Investigator and a Computer has been provided.
